## 2024 Victoria Estates Resident Street Parking Permit (RSPP) Application Instructions

Archon Protection's **RSPP system** has been designed to enhance community security and expedite notifications in cases of emergency. Variances will be issued only to Victoria Estates' residents under the following circumstances\*:

1. You must submit a copy of **each vehicle's registrations that are listed below.**
2. Each of the 5 or more vehicles are currently registered with the CA DMV to the applicant's Victoria Estates address.
3. The application below is filled out accurately in its entirety.
4. All resident vehicles must be registered with the Association on a current Resident's Confidential Data Sheet.
5. If an RSPP is provided, the vehicle must be parked directly in front of the residence, or to the side if on a corner lot, and may not be parked at any other location.
6. RSPP's may only be issued for the number of vehicles safely parked directly in front of the residence (and on the side in the case of a corner lot).
7. The Association is not obligated to provide any on-street parking, and an RSPP may be withdrawn if the owner or resident is not in compliance with the Association's Rules and Regulations.
8. Only guest vehicles displaying the proper pass or resident vehicles displaying an RSPP will be allowed to park on the street between the hours of 12:00 a.m. and 6:00 a.m.
9. Parking enforcement for expired 2023 stickers will begin January 1<sup>st</sup>, 2024.
10. **The resident's garage MUST HAVE two of the registered vehicles (two non-permitted vehicles) PARKED INSIDE the garage at the time of inspection as well as two or more of the registered vehicles parked on the driveway or else an RSPP will NOT be issued.**

### Limitations:

- a. RSPPs will be limited to 1 (one) per household, unless approved by the Board of Directors.
- b. RSPPs will be issued by the HOA's Security Company: Archon Protection.
- c. RSPPs will not be issued to accommodate with storage of non-operating or non-registered vehicles.
- d. RSPPs automatically expire on December 31<sup>st</sup> of the year they are issued.
- e. The owner must be current in all obligations to the Association.
- f. RSPPs may NOT be transferred to any other vehicles than the one they are issued to.
